**Important Notice**

Subject: OH candidates of CGLE-2021 examination seeking exemption from appearing in DEST

“As per Para No. 13.12.1.4 of Recruitment Notice CGLE-2021, “OH candidates opting for the post of Tax Assistant in CBDT are exempted from appearing in Skill Test, provided such candidates submit a Certificate in the prescribed format (Annexure-XVI) to the Commission from the competent Medical Authority, i.e., the Civil Surgeon of a Government Health Care Institution declaring him to be permanently unfit for the Typing Test because of a physical disability. OH candidates opting for post of Tax Assistant in CBEC and UDC/ SSA in Central Bureau of Narcotics are not exempted from Skill Test. All other PwD candidates are **not** eligible for exemption from the Skill Test.”

2. Exemption is allowed **only for DEST. (For the post of Tax Assistant in CBDT only, Not for any other post in this Recruitment)**

3. The OH candidates qualified for DEST may, in their own interest, send a request along with scanned copies of following documents on email ID: [sscmprraipur88@gmail.com](mailto:sscmprraipur88@gmail.com), **latest by 02.01.2023. Document received after 02.01.2023 will not be considered.**

- (i) **Medical Certificate** seeking exemption in prescribed format (**Annexure XVI** of the notice of Examination) from the competent Medical Authority, i.e., the Civil Surgeon of a Government Health Care Institution. It is again reiterated that candidates submitting Annexure-VI should ensure that the certificate has the following:
  - (a) Issued by Civil Surgeon.
  - (b) Clearly indicate how the disability interfere with Typewriting.
  - (c) Description of disabilities.
  - (d) Percentage of disabilities
- (ii) **Undertaking** as per the format annexed to this notice (Copy enclosed).

4. The decision of the competent authority on grant of exemption will be conveyed to the candidate on or before the day of Skill Test.

5. The candidates are required to produce all these documents **in original** before the Commission, if they are called for document verification.

6. PLEASE NOTE:

- (i) OH candidates opting for post of Tax Assistant in CBEC, UDC/SSA in CBN are not exempted from DEST.
- (ii) HH and VH candidates are not eligible for exemption from the Skill Test.
- (iii) No exemption from CPT is allowed for any category of PwD candidates.
